- < Electric utility switched to another plan to save money
- < advertising is expected to exceed budget. October actual does not show the cost for recent ads for new hires
- < enrollment is unchanged
- < Kara will need documentation for the hourly rates of the selected law firm

Review of Fiscal Policies

Many sections of the draft policies were reviewed

- < Changes to 'table of contents and references for consistency
- < Discussion of 'dual signatures'
- < Decision to add Assistant Charter Leader as an authorized signer for checks
- < Tagging of property is mainly limited to technology and media for capitalization
- < Procurement thresholds suggested in draft are lower than our current
- < Decision to keep current thresholds
- < Expected to review updates in November and present to Board in December
